Services are provided in a manner that protects the dignity of the individual, without regard to religion, race, color, national origin, creed, handicap, sex, number of pregnancies, marital status, age, sexual orientation, or contraceptive preference. Individuals will not be coerced to receive services in regards to using or not using any particular method of family planning.

Healthy Michigan, Medicaid, BCBS and most other insurance plans accepted.

We accept cash, checks, credit and debit cards for payment due at the time of the visit.
